Instructions

This acknowledgment form is to be used by contractors to certify that all construction activity on the property described in the form is completed according to approved Stormwater Drainage and Site Plans, and that all grading, sloping, and erosion controls comply with those plans. This form should be given to the property owner at completion of the Contractor's work.

The authorized person signing this form on behalf of the contractor should be someone familiar with the construction completed on the property or someone who has reviewed the construction notes and inspections and can confirm that the certifications made in this form are accurate.

Contractors pro	oviding this form to the property owner are responsible for:
	Filling out the property description at the top of the form;
	Attaching copies of the Stormwater Drainage Plan and the Site Plan

 \square Checking the appropriate box regarding site stabilization.

The Site Plan referred to in this form is the plan required by Wisconsin's Uniform Dwelling Code and Wis. Admin. Code § SPS 320.09(5)(a).

A property is stabilized if a perennial vegetation cover has been established with a density of at least 70%. Wis. Admin. Code § SPS 321.125(1)(c).

The Stormwater Drainage Plan and the Site Plan attached to this form should be clearly marked or labeled for identification purposes.

Both the contractor and the property owner should receive copies of the completed form.

NOTE: IF CONSTRUCTION DISTURBS MORE THAN ONE ACRE, THEN EITHER THE CONTRACTOR OR THE OWNER WILL NEED TO OBTAIN THE NECESSARY PERMIT FROM THE WISCONSIN DEPARTMENT OF NATURAL RESOURCES, AND THE ENTITY OR PERSON THAT OBTAINS THE PERMIT SHALL HAVE THE RESPONSIBILITY OF CLOSING THE PERMIT.
